Kittitas County Community Development Services (CDS) received your Winemakers Cabins (LPF-21-00007) Final Long Plat submittal on July 21, 2021. Kittitas County staff have completed a review of your final plat submittal. As provided below, staff has the following comments, requirements, and/or revisions for your application that need to be addressed prior to final approval and signature of the final plat mylars:

In addition to the notes above, your proposal does not appear to be consistent with Exhibit F-1, C-21-23 of the Suncadia Development Agreement. Yakama Nation has identified several issues with the survey conducted and informed CDS of the discrepancy. Please see their comment letter attached and work with them to resolve the issues noted. Final Plat signature will require a demonstration of consistency with the Development Agreement sections noted above.

Please submit your final mylars with the requested changes at your earliest convenience. As you are aware, RCW 58.17.140 allows for a thirty-day review window for complete Final Plats. Once we receive a resubmittal of the final mylars with requested changes we will initiate the 30 day approval window.
