- Parcel #'s 954945 and 954946 should be added to the certificate of the county assessor and certificate of county treasurer as well.

### Prosecuting Attorney:

 Prosecuting Attorney reviewed and approved current plat note #10 regarding language related to stick-built homes. No additional information is needed.

Please submit your final mylars with the requested changes within 60 days (November 19, 2021 at 5 PM). As you are aware, RCW 58.17.140 allows for a thirty-day review window for complete Final Plats. Once we receive a resubmittal of the final mylars with requested changes we will initiate the 30 day approval window.
