- 3. BEARINGS SHOWN WERE ESTABLISHED FROM PLAT OF RECORD. RELATIVE TO THE SOUTH LINE OF THE SOUTHWEST QUARTER OF SECTION 11 BEING NORTH 89'54'36" WEST.
- 4. SECTION SUBDIVISION CORNERS WERE ORIGINALLY SET BY GLO SECTION SUBDIVISION CONTRETS WERE UNIVALLY SEL BY GLU
 SURVEYOR HEZEKIAN JOHNSON IN 1907. ROCK WITH "X" WAS
 INDICATED FOR SOUTHWEST CORNER OF SECTION 11 ON SURVEY
 15—177. STONE WAS INDICATED FOR SOUTH QUARTER CORNER
 OF SECTION 11 ON PLAT OF SKI TUR VALLEY — VIKINGDAL DIVISION. IN 1973 BOTH CORNERS WERE RELOCATED AND 3" BRASS CAPS WERE SET BY THE BUREAU OF LAND MANAGEMENT. CORNERS WERE VISITED BY THIS OFFICE IN JULY, 1993 & 2008 AND 3" BLM BRASS CAPS WERE FOUND.
- CENTER COORDINATE POINTS OF LOTS WERE ESTABLISHED BY HOLDING THE COORDINATE OF THE SOUTH QUARTER CORNER AS SHOWN ON THE PLAT OF RECORD AND ADJUSTING THE COORDINATE OF THE SOUTHWEST CORNER TO MATCH THE MEASURED DISTANCE BETWEEN THE SUBDIVISION CORNERS.
- BEARINGS AND DISTANCES IN PARENTHESIS () ARE FROM PLAT OF RECORD, ALL OTHERS ARE BY ACTUAL MEASUREMENT.
