

## VERTICAL DATUM:

THE ELEVATIONS SHOWN HEREON ARE FROM AN ASSUMED VERTICAL DATUM. THEY ARE ONLY TO SHOW THE RELIEF OF THE LAND AND DO NOT REPRESENT THE TRUE ELEVATION ABOVE SEA LEVEL.

#### **CONTOUR INTERVAL - 1 FOOT:**

THE CONTOURS SHOWN HEREON WERE COMPUTER GENERATED FROM DIRECT FIELD OBSERVATIONS WITH RESULTING ACCURACY THAT MEETS OR EXCEEDS NATIONAL MAPPING STANDARDS, ONE-HALF THE CONTOUR INTERVAL.

#### PROJECT BENCHMARK:

TOP OF REBAR AND CAP MARKING THE SOUTHEAST PROPERTY CORNER OF LOT 16-34 OF SUNCADIA -PHASE 3, DIVISIONS 15 AND 16 (TUMBLE CREEK). ELEVATION = 2196.01'.

#### **GENERAL NOTES:**

- THE PURPOSE OF THIS SURVEY IS TO SHOW THE EXTERIOR BOUNDARY LINES, IMPROVEMENT SETBACKS LINES, EXISTING SITE IMPROVEMENTS, NATURAL FEATURES AND EXISTING TERRAIN FOR LOTS 16-34 AND 16-35 OF SUNCADIA-PHASE 3, DIVISIONS 15 AND 16 (TUMBLE CREEK), IN THE COUNTY OF KITTITAS, FOR THE INTENDED USE OF A PARCEL COMBINATION TO BE FILED SEPARATELY WITH KITTITAS COUNTY.
- 2. THIS SURVEY WAS PERFORMED USING A TRIMBLE S SERIES, 3" TOTAL STATION WITH RESULTING ACCURACY THAT MEETS OR EXCEEDS STANDARDS PER WAC 332-130-090.
- 3. THE INFORMATION ON THIS MAP REPRESENTS THE RESULTS OF A SURVEY MADE IN JULY OF 2021 AND CAN ONLY BE CONSIDERED AS INDICATING THE GENERAL CONDITIONS EXISTING AT THAT TIME.






