Enclosed please find the Rezone and Large Lot Plat Applications, SEPA Environmental Checklist and associated materials for the above referenced project. Terra Design Group, Inc. authorized agent for The Ranch on Swauk Creek LLC landowners, applied for a project specific Planned Unit Development (PUD) rezone and associated 4-lot Large Lot Plat on approximately 445.69 acres of land that is currently zoned Agriculture-3 and Agriculture-5. The Planned Unit Development is for the phased development for a total of 250 residential units. The project is located east of the City of Cle Elum off of Highway 97 and Bettas Road, Cle Elum, WA 98922 located in a portion of the NW ¼ Section 3, T19N R17E, and South ½ of the SW ¼ Section 27 and W ½ Section 34, all in T20 R17E, W.M., in Kittitas County. Map numbers 19-17-03000-0002, 20-17-27030-0007, portions of 20-17-27030-0005, 20-17-34000-0006, 20-17-34000-0002.

At the end of the comment period an environmental threshold determination will be issued pursuant to RCW 43.21C (State Environmental Policy Act) and WAC 197-11-355 (Optional DNS process). This may be the only opportunity to comment on the environmental impacts of this proposal pursuant to the State Environmental Policy Act. A Determination of Non Significance (DNS) is expected to be issued. A copy of the threshold determination will be available to the public upon request.
