## Description of proposal - Wanapum Right Bank Stabilization Project

In May 2018, due to high run off flows of the Columbia River, the right (west) bank near the Wanapum avian tower 4 required emergency stabilization. The shoreline was armored 100 yards downstream and 100 yards upstream of avian tower 4. Grant PUD is proposing to armor approximately 300 yards of the shoreline on the right (west) bank from avian tower 4 to the Wanapum dam. All work will be completed landward of the Ordinary High Water Mark and during low/normal lows so no in-water work will occur. Stabilization efforts include using an excavator/backhoe to level the bank (e.g. pull it back) to allow for safe access with a front-end loader near the edge of the bank. The rip rap (~24-inch diameter) will be added to the bank using dump trucks and front loaders to provide stability to the remaining 300 yards of the shoreline to prevent further erosion and damage to the avian tower.

## Location of proposal:

From I-90, take the Huntzinger Road exit and travel south on Huntzinger Road for approximately 6 miles to Wanapum Dam (will be on your left). The project site is located within the secured perimeter of Wanapum Dam. Township 16N, Section 20, Range 23EW of Kittitas County.
