Karen,

I have attached a pdf of some powerpoint slides that depict the area and should help in understanding the project. I am viewing the project as a repair of existing, serviceable shoreline works (riprap bank protection). I have some old permit information in my files circa 1996....but I am not clear when the <u>original</u> project went in. (I do recall the November flood in 1995 caused quite a bit of erosion upstream of the bridge and that could have easily resulted in significant erosion on the O'Leary (Monroe) property. So possibly some work was done then.)

I have also attached a rough draft of what I am considering for the HPA. I am waiting to review/discuss some additional drawings Ms. O'Leary has prepared for the Army Corps in support of her project. (I expect the Corps will exempt the project as a repair.)

River flows have been dropping so the bank toe at the site is readily visible and one can fairly easily walk along the river edge to inspect it.
