Dear Kylee Watkins:

On October 27, 2022, the Department of Ecology (Ecology) received notice that Kittitas County (County) has approved with conditions your application for a Substantial Development Permit (SDP) for the renovation of North Jetty Cove. The project includes the removal of electrical infrastructure, removal of underwater structures left over from a dock removal, removal of a fountain pump, and the installation of dedicated buoy/rope across the marina entrance. There will be the addition of amenities such as bollards, handrails, picnic tables, benches, trash cans, and the removal of invasive vegetative species that may exist. The project is located within Section 29 and 20, Township 17N, Range 23E with the Urban Conservancy and Aquatic shoreline environment designations along the Columbia River.

By law, local governments must review all SDPs for compliance with:

- The Shoreline Management Act (Chapter 90.58 RCW),
- The SDP approval criteria (WAC 173-27-150), and
- The Kittitas County Shoreline Master Program.

Local governments, after reviewing SDPs for compliance, are required to submit them to Ecology. We have received your SDP.

**What Happens Next?**

Before you begin activities authorized by this permit, the law requires you wait at least 21 days from October 27, 2022 the "date of filing." This appeal period allows anyone (including you) who disagrees with any aspect of this permit to appeal the decision to the state Shorelines Hearings Board (SHB). You must wait for the conclusion of an appeal before you can begin the activities authorized by this permit.
