Location: Two tax parcels (#15102 & #866033), located approximately 3.43 miles Northwest of Ellensburg, WA, in a portion of Section 8, T. 18 N., Range 18 E., W.M.; Kittitas County parcel map numbers 18-18-08020-0003 & 18-18-08020-0002, with a land use designation of Rural Working and zoning designation of Agriculture-20.

Notice is hereby given that on November 14, 2024, conditional preliminary approval was granted to McIntosh Excavating LLC (Landowner) for a short plat application to subdivide 41.16 acres into one (1) 10.26-acre lot, one (1) 15.30-acre lot, one (1) 9.25-acre lot, and one (1) 6.35-acre lot, utilizing the "New Small Lots Around Existing Residences" section of Kittitas County Code 16.12.040.1. The subject property is zoned Agriculture-20 with a Rural Working land use designation.
