Martin Durkan, authorized agent for Bear Creek LLC, landowner, submitted a complete application on June 18, 2008 for a 4 lot Short Plat pursuant to Kittitas County Code 16.32 on approximately 12.06 acres of land that is zoned Rural-3. The subject property is located northwest of the Town on Ronald, north of Redwood Lane on Salmon La Sac Road, Ronald, WA 98940, and is located in a portion of Section 27, T21N, R14E, WM, in Kittitas County. Assessor's map number 21-14-27051-0004.

Written comments from the public may be submitted to Kittitas County CDS no later than **Friday, September 19, 2008**, after which a SEPA threshold determination will be issued pursuant to RCW 43.21C (State Environmental Policy Act) and WAC 197-11-355 (Optional DNS Process). This may be the only opportunity to comment on the environmental impacts of this proposal pursuant to SEPA, as a Determination of Non-Significance (DNS) is expected to be issued. A copy of this subsequent threshold determination will be available to the public upon request. This proposal may include, incorporate or require mitigation measures under applicable codes regardless of whether a Determination of Significance (DS) is issued and subsequent Environmental Impact Statement (EIS) is prepared.
