NOTICE IS HEREBY given that Ken & Anne Everaert, landowners, submitted a Setback Variance application on September 14, 2020 pursuant to Kittitas County Code 17.84 on approximately 3 acres of land zoned Agriculture 5. The proposal requests a 10-foot reduction from the 25-foot front lot line setback requirement in KCC 17.16, which would result in a 15-foot front lot line structural setback if the variance is approved. The subject property is parcel # 952803 located at 1071 Lower Peoh Point Rd, Cle Elum, WA approximately 0.7 miles east of the City of South Cle Elum, WA in Section 35, TWP 20, R 15. Appeals to an administrative land use decision may be filed within 10 working days with Community Development Services as outlined in Chapter 15A.07 of the Kittitas County Code. The current appeal fee is \$1540, however you are encouraged to verify fee prior to filing of an appeal.
