# Everaert Setback Variance (VA-20-00009)

Pursuant to RCW 36.70B.130 and KCC 15A.06, notice is hereby given that Kittitas County Community Development Services approves the Zoning Setback Variance for Mr. and Mrs. Everaert, landowners, to reduce the 25-foot front lot line setback requirement in KCC 17.16 by 10-feet, which would result in a 15-foot front lot line structural setback. The site is located at 1071 Lower Peoh Point Rd, Cle Elum, WA approximately 0.7 miles east of the City of South Cle Elum, WA in Section 35, TWP 20, R 15. Map number 20-15-35062-0001.
