Pursuant to RCW 36.70B.130 and KCC 15A.06, notice is hereby given that Kittitas County Community Development Services approves the Zoning Setback Variance for Mr. & Mrs. Frees, landowners, to reduce the 25-foot front lot line setback requirement in KCC 17.30A by 21.67 feet, which would result in a 3.33-foot front lot line structural setback. The site is # 951931 located on Saint Andrews Drive, approximately 0.16 miles east of the intersection of Saint Andrews Drive and Golf Course Road in Cle Elum, WA bearing Assessor's Map number 20-14-26000-0005 in Kittitas County.

An appeal of this land use decision may be filed within 10 working days by submitting specific factual objections and a fee of \$1550 to the Kittitas County Community Development Services at 411 N Ruby St, Suite 2 Ellensburg, WA 98926. The appeal deadline is 5:00pm on November 12, 2021.
