

NOTICE IS HEREBY given that pursuant to RCW 43.21(C), Kittitas County Community Development Services did on June 10, 2015 make a Mitigated Determination of Non-Significance (MDNS) for Jeff Slothower, agent for property owners Scott and Gayle McIntosh, for a Conditional Use permit application to operate a small scale event facility conducting more than eight events a year. The subject property is zoned Agriculture 20. Change of occupancy and final approval will be required. The application comprises 3 parcels, located approximately 5 miles northwest of Ellensburg at 7820 Highway 97, in a portion of Section 08, T18N, R18E, WM in Kittitas County, bearing Assessor's map numbers 18-18-08020-0002, 18-18-08000-0002, and 18 18 08020 0003. Any action to set aside, enjoin, review, or otherwise challenge such administrative SEPA action on the grounds of noncompliance with the provisions of chapter 43.21(C) RCW shall be commenced on or before **June 25, 2015 at 5:00 p.m.** to the Kittitas County Board of Commissioners, Rm. 108, County Courthouse, Ellensburg, WA 98926. NOTICE IS FURTHER HEREBY given that a hearing on said application before the Kittitas County Hearing Examiner has been scheduled for **June 25, 2015 at 6:00 p.m.** in the Kittitas County Courthouse, 205 W 5th AVE STE 108, Auditorium, Ellensburg, WA. 98926.
