NOTICE IS HEREBY given that Kittitas County CDS and the Kittitas County Hearings Examiner will meet at 6:00 p.m. on July 22, 2021 to conduct a virtual public hearing to consider the Ryegrass LPL Expansion Conditional Use Permit application (CU-21-00003). The proposed project would expand the existing limited purpose landfill by 16.6 acres.

NOTICE IS HEREBY given that pursuant to WAC 197-11-355, Kittitas County Community Development Services did on, June 24, 2021, issue a Final Determination of Non-Significance (DNS) for the Ryegrass LPL Expansion application (CU-21-00003).

The lead agency for this proposal has determined that it does not have a probable significant adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21C.030(2)(c). This

decision was made after review of a completed environmental checklist submitted in 2004, addendum to said checklist, other information on file with the lead agency and after considering mitigation measures required by existing laws and regulations that will be implemented by the applicant as part of the permit process. This information is available to the public on request.

This DNS is issued after using the optional DNS process in WAC 197-11-355. There is no further comment period on the DNS. Any action to set aside, enjoin, review, or otherwise challenge this administrative SEPA action on the grounds of noncompliance with the provisions of Chapter 43.21C RCW shall be commenced on or before July 9, 2021 by 5:00 PM.
