**Notice of Decision  
Zentz Rezone (RZ-13-00001)**

Pursuant to RCW 36.70B.130 and KCC 15A.06, notice is hereby given that the Kittitas County Board of County Commissioners approved the Zentz Rezone on October 1, 2013. Teresa Zentz landowner, applied for a project specific rezone on approximately 10 acres of land that is vested to Agriculture 3 zoning. The project is located 4 miles northwest of Ellensburg at 430 Klocke Road, in a portion of Section 20, T18N, R18E, WM in Kittitas County, bearing Assessor's map number 18-18-20020-0004.
