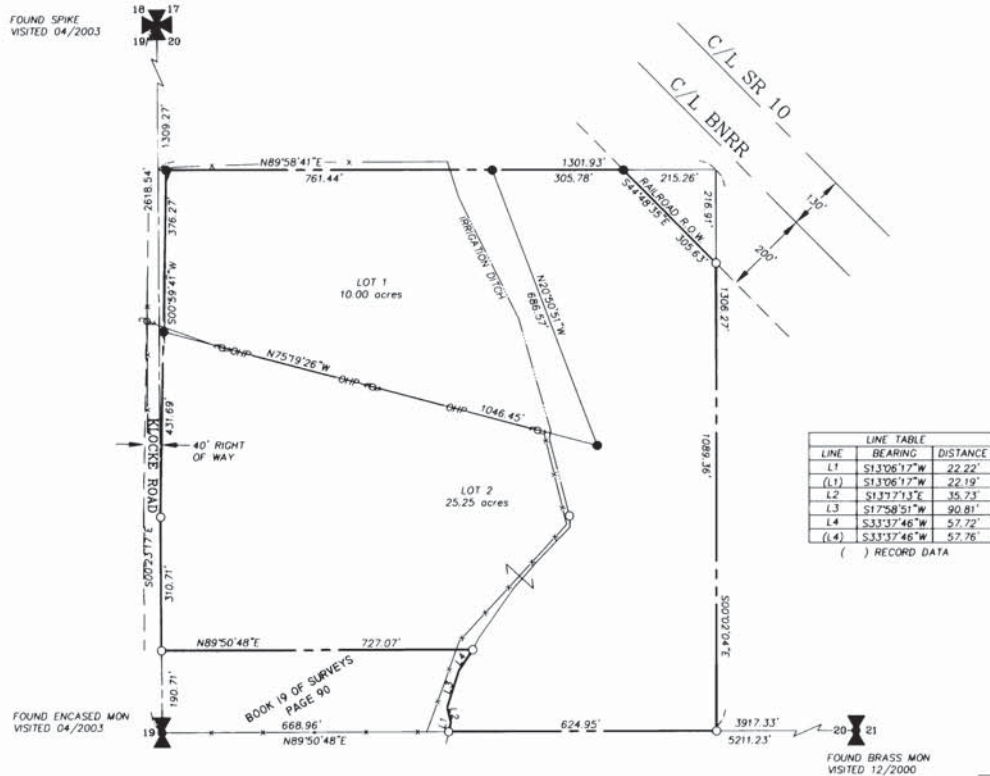

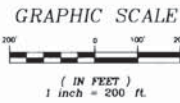
**NOTES:**

1. THE PURPOSE OF THIS SURVEY IS TO IDENTIFY THE EXTERIOR BOUNDARIES OF TAX PARCELS 18-18-20020-0004 AND 18-18-20020-0008 AND TO THEN ADJUST THOSE BOUNDARIES AS SHOWN HEREON.
2. THIS SURVEY WAS PERFORMED USING A NIKON DTM-521 FIVE SECOND TOTAL STATION. THE CONTROLLING MONUMENTS AND PROPERTY CORNERS SHOWN HEREON WERE LOCATED, STAKED AND CHECKED FROM A CLOSED FIELD TRAVERSE IN EXCESS OF 1.10,000 LINEAR CLOSURE AFTER AZIMUTH ADJUSTMENT.
3. FOR SECTION SUBDIVISION, CORNER DOCUMENTATION AND ADDITIONAL SURVEY INFORMATION, SEE BOOK 26, PAGES 4-7, AND THE SURVEYS REFERENCED THEREON THE BASIS OF BEARINGS SHOWN HEREON IS THE SAME AS SAID SURVEY OF RECORD.
