**Notice of Decision**

Wenger Short Plat (SP-07-00007)

Notice is hereby given that on June 27, 2016 conditional preliminary approval was granted to Mark and Darcy Wenger landowners, for a short subdivision of approximately 10.45 acres into one 3.36 acre parcel, one 3.52 acre parcel and one 3.53 acre parcel. The subject property is located approximately 7.5 miles west of Cle Elum at 4684 Nelson Siding Road, in a portion of Section 29, T20N, R14E, WM in Kittitas County, bearing Assessor's map number 20-14-29010-0010.

Short Plat Projects are processed administratively with the Planning Official making the final decision (Kittitas County Code {KCC} 16.32.050), which does not involve a public hearing. KCC Chapter 15A.07 describes the provisions for the appeal of an Administrative Decision and stipulates that an appeal of this land use decision must be filed within 10 (ten) working days by submitting specific factual objections. A filing fee of \$780.00 must accompany the appeal which is delivered to the Kittitas County Board of Commissioners at 205 West 5th, Room 108 Ellensburg, WA 98926. The appeal deadline for this project is **July 12, 2016 at 5:00p.m.** Original short plat documentation and related information may be examined during the business hours at the Kittitas County Community Development Services Department, 411 N.
