**Snoqualmie Pass Fire and Rescue  
Proposition No. 1**

**Property Tax Levy for Fire Protection and  
Emergency Medical Services**

The Board of Commissioners of Snoqualmie Pass Fire and Rescue adopted Resolution No. 2021-07, concerning a proposition to maintain and adequately fund District operations. This proposition authorizes the District to restore its regular property tax levy to \$1.00 per \$1,000 of assessed value to be assessed in 2021 and collected in 2022. The funds will maintain and improve fire protection, emergency medical services and facilities, replace apparatus and equipment, and provide for firefighter safety. The maximum allowable levy in 2021 shall serve as the base for subsequent levy limitations as provided by chapter 84.55 RCW.
