Kittitas County Jail Annual PREA (Prison Rape Elimination Act) Report

This report contains data for 2021 of all inmates booked and/or housed in the Kittitas County Jail (KCJ) located in Ellensburg, WA under the direction of the Kittitas County Sheriff's Office. The Kittitas County Jail is a 209-bed facility. The jail houses adult male and female inmates. This report includes incidents involving inmates under the authority, custody, or care including those held in separate holding or lockup areas within the facility. Excluded from this report are those inmates held in other jurisdictions.

ABUSIVE SEXUAL CONTACT

Sexual contact of any person without his or her consent, or of a person who is unable to consent or refuse;

AND

- Intentional touching, either directly or through the clothing, of the genitalia, anus, groin, breast, inner thigh, or buttocks of any person.

SEXUAL HARASSMENT

Repeated and unwelcome sexual advances, requests for sexual favors, or verbal comments, gestures, or actions of a derogatory or offensive sexual nature by one inmate directed toward another

For purposes of SSV, sexual abuse is disaggregated into two categories of staff-on-inmate sexual abuse. These categories are:

STAFF SEXUAL MISCONDUCT

Any behavior or act of a sexual nature directed towards an inmate by an employee, volunteer, contractor, official visitor or other agency representative (exclude family, friends or other visitors) Sexual relationships of a romantic nature between staff and inmates are included in this definition. Consensual or nonconsensual sexual acts include-

• Intentional touching, either directly or through the clothing, of the genitalia, anus, groin, breast, inner thigh, or buttocks that is unrelated to official duties or with the intent of abuse, arouse, or gratify sexual desire

OR

• Completed, attempted, threatened, or requested sexual acts;

OR

• Occurrences of indecent exposure, invasion of privacy, or staff voyeurism for reasons unrelated to official duties or for sexual gratification

STAFF SEXUAL HARASSMENT

Repeated verbal comments or gestures of a sexual nature to an inmate by an employee, volunteer, contractor, official visitor, or other agency representative (exclude family, friends, or other vistors.) Include-

• Demeaning references to gender; or sexually suggestive or derogatory comments about body or clothing;

- Repeated profane or obscene language or gestures.
