Division of Behavioral Health and Recovery, Community Prevention, and Wellness Initiative Funding Robin Read noted that she had sent out the standards for the Division of Behavioral Health and Recovery, Community Prevention, and Wellness Initiative Funding and asked if there were any other questions, and asked for direction on how to proceed. All BOH members were in agreement to move forward with contracting for public health to take on the program.

# Environmental Health code updates

Robin Read informed the Board of Health members of the history of the On Site Septic (OSS) code and that it has not been updated since 1979. Ms. Read noted that the department would use a quality improvement process, benchmarking, and obtain feedback from stakeholders when updating the code. Ms. Read noted that the Group B code is also being reviewed for changes/updates. The group discussed possible future regulations and funding related to the Joint Plan of Responsibility.
