Meeting called to order at 10:00 a.m.

Tristen Lamb stepped to the microphone and reported that the 2018 Public Health Fee Schedule and policy was approved on May 18, 2018. After approval staff discovered there was an error in documents submitted, which omitted a new fee that was intended to be added. Ms. Lamb is asking for approval of the amended 2018 Kittitas County Public Health Fee Schedule and policy, which includes the new meter inspection fee of \$385.00. The fee is added to accommodate the new metering project and code changes requiring all new domestic uses of water be metered through the county metering program, including those that mitigate through a private water bank.

There was a brief discussion about the \$385.00 fee and some members of the BOCC felt it was a little high. The BOCC would like the health department to look at the fee again next year and see if the fee is adequate for the work being done.
