Minutes

Department Updates

Administrator update

Tristen Lamb stepped to the microphone and briefly reviewed the following updates:

- Ms. Lamb thanked Dr. Asriel for his presentation last month.
- CBD oil is added to products at permitted food establishments in the state. Washington State DOH has requested that the FDA provide enforcement guidance for these activities as this is not approved for retail food service.
- The EH supervisor position is open, and there are a few applicants
- Erin Moore is currently on maternity leave.
- Sampling on drug contaminated property is complete and does not meet toxic level standards. The health department has rescinded health order.

 School health and safety inspections have been completed, and staff were cross trained in this program.

Health Officer Update

Mark Larson M.D. stepped to the microphone and noted that due to reduced hours in the water program, he will be able to spend time focusing on other areas of public health. A Wildfire Workgroup has been created to include Dr. Larson and others from around the state. They will develop standards on how to deal with wildfire smoke and communication to the public around the state. The group will meet once a month.

Dr. Larson discussed the news report from the New England Journal that came out about the major causes of death to kids. The top two major causes are motor vehicle accidents and firearms. Over the years motor vehicle accidents have gone down, while injuries with firearms have increased. Dr. Larson discussed firearm education with kids and families to increase awareness and ideas about how to approach this issue in the future.

Financial Update

Tristen Lamb noted that there was no monthly financial update due to the end of the year budget presentation later in the agenda.
