Meeting called to order at 10:00 a.m.

Tristen Lamb reviewed the staff report for the 2021 Public Health Fee Schedule. Ms. Lamb gave a brief overview of non-monetary, non-environmental health fee changes to the fee schedule policy, including language regarding clinic services, and vital records.

Jesse Cox gave the board an overview of the 2021 proposed changes to the environmental health fees, which included information regarding feedback from stakeholders and the decrease in fees, and wanting to see an increase in staffing. Mr. Cox reviewed three fee scenarios for the board; proposed fees as is, proposed fees adding an additional staff person at 0.6 FTE, and, proposed fees adding an additional staff person at 1.0 FTE.

There were questions from the board regarding OSS fees and staffing. Public health staff answered all questions.

Pat Deneen voiced concern regarding the fees for Group A Water System adequate water supply determination applications. Mr. Deneen requested the fee and time for processing be re-evaluated.

There was discussion about the Group A Water System adequate water supply determination application fees, and their breakout on the fee schedule, and fee methodology. The board expressed their support for hiring an addition full time staff member in the environmental health division.

COVID-19 Vaccine Update

There was discussion regarding vaccine distribution, and scheduling while accommodating possible immune response/reactions.

COVID/Health Officer Update

Dr. Larson updated the board on Central Washington University case and contact investigations, as well as testing of students. Dr. Larson also gave an update regarding COVID-19 and K-12 schools in Kittitas County. Rapid antigen testing in Kittitas County was also discussed. Dr. Larson discussed the new Center for Disease Control quarantine requirements. The new COVID notification system was also reviewed. Dr. Larson informed the board of the case numbers for COVID in Kittitas County following Thanksgiving and going into Christmas.
