# Introducing Dr. Mark Larson, Health Officer

If you live in Kittitas County, you may have seen Dr. Mark Larson at KVH Family Medicine or out hiking or at an Ellensburg Cross Country track meet. Or, you may have seen the awards he received in 2015 including the Dr. John Anderson Memorial Award for Outstanding Rural Health Practitioner or the Statewide Family Physician of the Year.



What some in the county may not know is that Dr. Larson has a second job! The Kittitas County Public Health Department has been fortunate to call Dr. Larson our Health Officer since 2006. The Health Officer, per state law, has broad powers and duties in protecting the health of the public. Powers and duties include enforcing local regulations and ordinances, controlling the spread of diseases, and taking such measures as necessary in order to promote public health.


Over his career, Dr. Larson has experienced pertussis and E. coli outbreaks, flu pandemic response, the start of a local syringe exchange, wildfires, water mitigation, and more. "Dr. Larson always has his eye on health equity and how his actions and the actions of our health department might affect people who lack resources," asserts Administrator Robin Read. "He strives to treat the public like he treats the staff here at KCPHD - taking the time to listen, ask questions, and generally care about an individual's well being."

Potential decisions that a Health Officer might face include isolation and quarantine, or closing food establishments or daycare facilities, or approving specific health orders requiring action of local agencies or property owners. "Dr. Larson is modest in his use of Health Officer powers," states Read. "He always focuses on prevention, but also balances what has to be done to maintain the health of our county."

# The Kittitas County Board of Health Advisory Committee Recognizes 2017 Public Health Champion

On April 28, 2017, The Kittitas County Board of Health Advisory Committee named the Kittitas County Early Learning Coalition as the 2017 Public Health Champion. "We felt that the Early Learning Coalition deserves this year's award because of their contributions to children's education," according to Andrew Lyons, BOHAC Chair. "Education plays an extremely important role in the health of children, families, and our community."

The Kittitas County Early Learning Coalition helps parents prepare their children ages birth through five for kindergarten entry. They sponsor events to engage parents and their young children in science, technology, reading and writing, engineering, art, and math. The Public Health Champion Award provides \$500.00 to the recipient for current or future projects that enhance the health of Kittitas County.





The mission of the Kittitas County Early Learning Coalition is to support school readiness by developing, supporting and strengthening parent child early learning programs by engaging children from birth until entrance into kindergarten, their parents, teachers, administrators and other community partners.

## **Kittitas County Public Health Champion Award**

The Kittitas County Public Health Champion Award is sponsored by the Kittitas County Board of Health Advisory Committee (BOHAC). The first award was announced in 2015 as a result of a monetary donation provided to BOHAC by Dr. Jim Gale. Dr. Gale was a previous Health Officer and felt that it was important to provide funds to BOHAC to further the mission of improving health through activities, policies, funding, and initiatives. Dr. Gale provided a \$6,000.00 award.

Since 2015, BOHAC has recognized the following individuals or agencies as Public Health Champions:

The Public Health Champion Award call for nominations goes out annually in February and award recipients are announced in April. ## 2017 Year in Review: Top Stories for KCPHD

#### **Narcan Saves Lives**

Narcan, or naloxone, is an antidote for opioid overdose and can temporarily stop the effects of the opiate (hydrocodone, oxycodone, morphine, and heroin are examples). KCPHD gave out 70 naloxone kits along with education about recognizing the signs of overdose and how to administer the medication in 2017, with two overdose reversals being reported to our department. KCPHD recommends that anyone who spends time with someone who is using, or suspected of using opioids, should carry naloxone and have overdose prevention training.

#### Water Access Expanded in Kittitas County

KCPHD partnered with the Washington State Department of Ecology (Ecology) to issue an "over the counter" (OTC) permitted water right for parcels located within a large portion of the green zone in Kittitas County. The new permit was the first of its kind in the state and allows for a more efficient process to customers. The new option for customers in the Wilson Creek/Cherry Creek meant a mitigation certificate could be issued in less than 10 days versus a 12 month permit process with Ecology. The OTC process is located in an extremely popular housing development area and covers most of the lower county.

## County works on plan to improve air quality PATH Forward Plan to Address Air Quality

In March of 2017, KCPHD completed the PM Advance Program: Path Forward Plan, which is a plan to avoid non-attainment in regard to air quality. Non-attainment means that an area has air quality levels that are not meeting national standards. The PM Advance Program is run by the Environmental Protection Agency (EPA) and provides support to communities to improve air quality. Projects under the plan include things like woodstove change outs, responding to smoke complaints, and providing air quality education.



## 2017 Year in Review: Top Stories for KCPHD



#### **Tobacco and Electronic Vape Product Prevention and Control**

2017, the Kittitas County Board of Commissioners and Board of Health approved voted to amend Kittitas County Code to include designated smoking and vaping areas at the Kittitas County Event Center. With the new amendment, designated smoking and vaping areas were effective for the 2017 Fair. KCPHD worked with the Kittitas County Fair Board and Event Center staff to identify designated areas, provide signage, and promote the code change.

#### **KCPHD** and City Partners Address Complete Streets

In January, the City of Cle Elum and the City of Ellensburg were selected for the Complete Streets Award from the Transportation Improvement Board. Cle Elum was awarded \$125,000 and Ellensburg received \$250,000 to pursue infrastructure projects that allow everyone safe access to walking, biking, or riding/driving in an automobile. Both cities were nominated by KCPHD, since both municipalities have adopted complete street ordinances.

#### **KCPHD** Responds to the Jolly Mountain Fire

In 2017, KCPHD was out in the field for emergency response to the Jolly Mountain Wildfire- testing indoor air quality for schools, ensuring multiple distribution sites for N95 masks, answering phones at the Emergency Operation Center (EOC), providing logistical support in the EOC, and putting out public messaging about changing air conditions, school air monitoring, and temporary shelter information.




