SANITARY PRIVY / COMPOST TOILET PERMIT APPLICATION

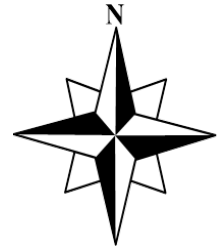
1. Sanitary privies or vault toilets may be used in areas where no suitable domestic water supply is available, or in combination with an approved on-site grey water system
2. No privy or vault toilet may be constructed and/or located on any property without having first obtained a written permit from the health officer, in accordance with WAC 246-272A-0200 and Kittitas County Code
3. All sanitary privies shall use a sealed vault and be constructed and maintained to have the waste receptacle contents inaccessible to rodents, vermin, and vectors.
4. No privies are allowed in the floodway.
5. In floodplain areas, contact the CDS Planning Department for information relating to Shoreline Management Plan.
6. The Declaration of Covenant (attached) must be completed, recorded with the Kittitas County Auditor's Office and a copy of the recorded document must be submitted with this application.
