If mailing your registration, the form must be **received** by 2/3/20.

**February 11, 2020** – **Last day for new & transfers- must be** IN PERSON at the office of the Kittitas County Auditor up to 8:00pm election day.

Registration assistance and voting aides are available for the elderly, disabled, or anyone that requests additional assistance.

ADA compliant voting equipment is available for use in the Auditor's Office- Kittitas County Courthouse, Room 105, beginning Friday, January 24, 2020, continuing weekdays through Monday, February 10<sup>th</sup> from 9am to 4:30pm, and on Election Day, from 9am to 8pm.
