## Budget in Brief — 2021

#### **Budget Summary**

The total county budget is \$116,735,415. The total county budget is set up by fund types by revenue and expense category, and departments within the funds. The general fund is 39% of the county budget, while the special revenue funds are 41%. The budget is made up of 36 county funds; one general fund, twenty-six special revenue funds, two debt service funds, two capital projects fund, four proprietary funds and one trust fund. The largest of all these funds are the General Fund and the County Road Fund.





### Revenue Summary

The biggest revenue source as seen in the chart is Taxes with an amount of \$17,833,830. This includes: Personal Property, Retail Sales, Use, Special Sales, Lodging, and Admissions Tax. Next would be the Intergovernmental Revenues with an amount of \$6,881,717 that are received from other government for grants, charges for service, and payment in Lieu of taxes.
