DEVELOPMENT PLAN RANCH ON SWAUK CREEK PUD REZONE

Dan Carlson, Director of Community Development Services reviewed a Staff Report. He provided information on the Ranch at Swauk Creek Planned Unit Development Rezone (RZ06-00027) which is a project consisting of a total of 243 lots to be developed in three phases on 487.43 acres located west of US Highway 97 and south of Ranch Road and Burke Road. The project also includes 146 acres of open space, including protection of Swauk Creek, continued agricultural uses, passive and active recreational activities, and a proposed community center. He reviewed other requirements and recommended approval of the request.

Chad Bala, Terra Design Group indicated they would not have any issue with adding the language proposed by the Board relating to Open Space

and ensuring it's maintained by ownership by the landowner within the development. Pat Deneen said that was their intent to have a family ranch with approximately 400 acres and will have cattle, farming on one big tract. He did not have any issue with adding the language as proposed.

Commissioner Osiadacz moved to approve the Ranch at Swauk Creek Planned Unit Development Rezone Final Development Plan (RZ-06-00027); add language relating to Open Space and how it is maintained by the ownership of the landowners within the development; and direct Staff to prepare enabling documents. Commissioner O'Brien seconded. Motion carried 3-0.
