He stated that Carolyn Honeycutt from the EDA had contacted him with some concerns and now the Agreement is much more specific as to what the funds can be spent on. He stated that Ms. Honeycutt has already signed the revised Agreement and is before the Board for consideration and signature.

Commissioner Osiadacz moved to approve and authorize Board signature on the revised EDA 2017 Lodging Tax Services Agreement. Chairman Jewell seconded. Motion carried 2-0.

UPDATE BOCC/ DEPARTMENT HEAD REPORTS COMMISSIONERS
