There was discussion on the ability to have a range that's open year round that would be a benefit to local law enforcement etc. There was discussion on other parties that may be interested in the use of the proposed facility. There was further discussion on potential long term plans/ideas.

Chairman Jewell stated that the Board should know a CUP would be a requirement of the property for it to be used as a gun range. There was discussion on potential interest of lessors of the gun range. The Board expressed their support for the idea. Commissioner Osiadacz stated she was disappointed the location was not in the
