ORDINANCE

**AMENDING CHAPTER 2.04 OF THE KITTITAS COUNTY CODE ESTABLISHING
OFFICIAL MEETING TIMES AND THE TIME OF REGULAR STUDY SESSIONS FOR
THE KITTITAS COUNTY BOARD OF COMMISSIONERS.**

WHEREAS, Kittitas County Code 2.04.010 establishes the official meeting times of the Board of County Commissioners, and

WHEREAS, The Board of County Commissioners has determined that changing the time and date of the Solid Waste/ Maintenance /Fair Office Regular Study Session was needed to conduct routine administrative business , and

WHEREAS, The Board of County Commissioners held a public hearing on Tuesday August 19, 2014 to consider public testimony on official meeting times for regular meeting times and the regular study sessions, and

WHEREAS, The Board of County Commissioners felt it was in the best interest of the public that these meeting times be adopted by Ordinance to properly inform the public of the dates these meetings will be held for purposes of conducting the business of the county, and

BE IT HEREOFRE ORDAINED, Kittitas County Code 2.04.010 is hereby amended and to take effect September 1, 2014:

2.04.010 - Official Meeting Time.

The first and third Tuesday at 10:00 a.m. of each and every month of the year is designated as the regular meeting date of the Board of County Commissioners, to be held at the Kittitas County Courthouse located at 205 West 5th, Room 109, Ellensburg, Washington, at which time all of the normal business of the County will be transacted; provided that if Tuesday falls on a holiday, such regular meetings shall be held on the next business day. Should another time be required for any business, prior notice will be given for such special meeting in accordance with the law.
