Jeremiah - Almost every tax parcel acreage is not correct if it has not been surveyed previously. This could be 0.01 acres up to 10 or more acres. You will see this conflict on most BLA applications adjusting parcels that have not been surveyed previously. The final areas will be certified on the recorded survey and the Assessor will update tax records to match. The areas we list for final are based on our calculated boundaries for the final parcel configurations. This issue is not as common as most properties have been surveyed previously. Might review the Niehoff BL-21-00012 application as the surveyed areas were 25+ acres different then assessed.

Additionally, the Assessor will adjust any tax parcel area to match a recorded survey upon request.
