Dear Ms. Bacon,

I am writing this letter to express Yakama Nation's concerns on ground and surface water issues within the property under consideration for a conditional use permit (CU-23-000001 3 BR Custom Cuts). The SEPA application states that this area is predominantly graded gravel. However, looking at aerial imagery, it appears there are moist soil areas (potential wetlands) within this property boundary. The neighboring property to the south (same owner) has emergent freshwater wetlands present, and it appears that this wetland expands northward into the property under consideration. Having wetlands present generally means groundwater is close to the surface throughout the calendar year. This property also sits on the alluvial fan of Wilson and Naneum Creeks. Alluvial fans are excellent sources of surface and groundwater exchange in natural systems. Using NHD flow lines to view water potential of this area, it appears the aforementioned wetlands could be the source of origination for Lyle Creek. Sources of potential contamination from commercial production that may harm Treaty Reserved resources are not taken lightly by the Yakama Nation.

Secondly, the Yakama Nation request developing a detailed water use plan for this proposed facility. The average rural resident in Kittitas County uses 192 gallons per day, which means this facility will be equivalent to 16 new homes using the existing well. It is unknown or not well documented if the current well proposed for use can withdraw that much water without impacting the aquafer, instream surface water levels, or their neighbor's ability to receive fresh, clean water.

For these reasons, we feel that a proper groundwater analysis needs to be performed by a licensed geomorphologist. A clear understanding of the interaction between surface and groundwater will give a better view of the potential for this project to impact Treaty Reserved resources.
