The proposed project will host a miniature golf course area with a log house on premises, which will include restroom facilities, retail, rental and dining facilities, and may include a putting green. There will be two areas for lodging sites that may include a bed and breakfast with 12 rooms and or a hotel/motel with 60 rooms with a parking space for each room. The subject parcel is General Commercial in a LAMIRD Type I Zoning with a LAMIRD land use designation. Mini Golf is allowed in this zone with a Conditional Use Permit under KCC 17.15.050

NOTICE IS HEREBY given that pursuant to WAC 197-11-355, Kittitas County Community Development Services did on, May 1, 2024 issue a Final Mitigated Determination of Non-Significance (MDNS) for the Roslyn Ridge Mini Golf Conditional Use application (CU-23-00005).

The lead agency for this proposal has determined that it does not have a probable significant adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21C.030(2)(c). This decision was made after reviewing a SEPA environmental checklist and other information on file with the lead agency and after considering existing laws and regulations that will be implemented by the applicant as part of the permit process. Timely appeals must be received no later than May 17, 2024 by 5:00 PM.
