If you could please give me a call at your earliest convenience regarding the revised survey comments, or verify by email that the below positions are correct so we don't have any unknown hurdles for our preliminary plat for P1D14:

It is our understanding the third survey comment #8 is resolved as CDS has confirmed Suncadia is allowed under the Development Agreement to plat prior open space parcels as long as the owner (SCC) is shown on the cover of the plat and that Exhibit M is updated to reflect.

Comment #6 appears to be a conditional preliminary plat comment to be resolved prior to final as the road labelling as commented/requested is found only in the final plat part of KCC.

Comment #4 also appears to be a conditional preliminary plat comment and does not pertain to the

easements yet to be determined as construction documents/etc. are finalized prior to final plat. It seems this comment/code is stating to show any 'existing easements' that would be on this property, of which there are not any in this instance.

It would be of tremendous value for the next plat review if Survey can classify if the comment is conditional for final, or required per certain County code section so we aren't guessing if it is or not.

Following up with you in regards to our P1D14 preliminary plat public works comments to ensure we are good to go. As discussed yesterday, we did submit an amended set to Kelly/CDS on 11/2/22 and you mentioned you received those, however, the comments we were forwarded by CDS on Monday this week (11/14) to address prior to confirming public hearing are the same comments that got addressed in the 11/2 amended set? Please verify Public Works has received the amended set addressing the survey comments and that we are good to go with preliminary plat.

I also clarified Public Works Survey comment #4 (copied below) with our civil engineer and essentially that comment does not apply to preliminary plat / Suncadia.
