The Department of Health (DOH) Office of Drinking Water (ODW) has the following discussion (the following is an update of a previous DOH communication dated 10-25-2022) regarding water availability based on the additional proposed connections identified in the "Suncadia Social Plat" application:

Based on previous communications regarding previous applications, the following table of proposed connections was provided:

At this time, DOH records show the following:

- 1501 approved connections
- 992 active (constructed and occupied) connections (prior to the construction of any

of the proposed developments)

Then,

• 522 (= 221 + 301) proposed connections

This then gives, when all are constructed and active:

• 1514 (= 992 + 522) active connections

So, after the construction of this set of proposed connections, the water system would be over-connected by have 13 (= 1514 - 1501) connections.

At this time, DOH records show 1040 active connections, so some of the proposed units shown in the tables have been constructed. But, the water system remains within its approved connections, based on existing capacity and connections.

DOH also notes that Suncadia has submitted an updated Capacity Analysis that DOH has reviewed and is awaiting an updated submittal from Suncadia addressing our comments – but the completion of the capacity analysis appears to be somewhat "urgent", to provide time for the design, review, and construction of any needed drinking water infrastructure to provide upgraded capacity.
