Kittitas County Community Development Services is requesting comment on the Shoreline Substantial Development (SD-22-00001) and Public Facilities (PF-22-00001) applications for the North Jetty Cove Project.

The proposed project includes removal of electrical infrastructure such as light posts, pedestals and vaults, the removal of underwater structures left over from dock removal, the removal of fountain pump, and the installation of a dedicated buoy/rope across the marina entrance, and added amenities such as bollards, handrails, picnic tables, benches, trash cans, and the removal of any native vegetative species that may exist.
