Kelly,

Holly will be reaching out to the Zipperers about what is still required this morning. I went through the preliminary approval that was sent out and it states that "The applicant shall demonstrate proof of water adequacy in conformance with KCC 13.35 prior to final plat approval." I think the break down here is that more conditions were required on the PH comment prior to the final plat approval then just the soil logs and adequate water supply determination 13.35. Our B-2 section of the comment has some specifics that have not been met such as "All individual, and shared wells must meet the distance requirement of 50 feet from the property line." This is critical because in their correspondence they have indicated that they plan to use individual wells for each new parcel and wells placed within the setback would be in violation of KCC 13.20.040. As of right now we are missing two components to approve the short plat the first is that they have not completed all that is required in 13.35 per preliminary approval because it requires the wells to be drilled prior to an adequate water supply determination, and the second being the placement of the boundary line within 50 ft of the existing well which is noted in PH comments under "Prior to Final Plat Approval". After speaking with Arden about a water right issue they are having I believe she is wanting to set up a meeting with PH, PW, CDS and the applicant to go over this particular plat and to clear up what all is needed. Moving forward Public Health is completely open to changing our comment format or language if needed to better facilitate our requirements and to help aid in a smoother process. Anyway, I am sure we will get this resolved in a timely manner thank you for facilitating this.
