Thank you for the opportunity to comment on the driveway proposal with parcels 546534 and 516534 in Section 05, T. 19 N., Range 16 E., W.M.; Kittitas County.

Based on remote review of this parcel(s) it appears that some or all of the parcel(s) consist of forestland, and it will require a Forest Practices Application (FPA) from the DNR if merchantable timber is removed/harvested as part of the proposal and/or is being converted out of forest land (RCW 76.09 and WAC 222). The FPA would need to meet the requirements of the Forest Practices Act and its rules. It is our recommendation that the applicant meet with our local forest practices forester to discuss, they may call our Southeast Region office at (509) 925-8510 to schedule an appointment.

Dear Mr. Gasawski,

Thank you for the opportunity to comment on the Horish Reasonable Use application for the proposed driveway and subsequent future residence on parcel 516534. The Washington Department of Fish and Wildlife (WDFW) previously provided comments on this project under the Shoreline Variance application (SV-23-00001) which we'd like to incorporate by reference with this letter. The Yakima River is dynamic in this reach with several active side channels and associated wetlands and frequently flooded areas. It's important to recognize these riverine processes to protect them and the functions and values they provide for fish and wildlife in addition to ensuring public safety is considered in and around these Shorelines and Critical Areas.




Figure 1: This image comes from Page 9 of the Critical Areas Report submitted with the Horish Reasonable Use application. It clearly shows Wetland D in direct connectivity with the OHWM of a Type S water near the bottom right of this image.

The Kittitas County Code 17B.01.020 defines the scope and jurisdiction of Shorelines in Kittitas County to include "all shorelines of the state; upland areas (shorelands) within two hundred (200) feet of the ordinary high water mark of those waters; associated wetlands and river deltas; and floodways and contiguous floodplain areas landward two hundred (200) feet from such floodways." The wetlands identified in the critical areas report are directly associated with the Yakima River, a shoreline of statewide significance, and are subject to the Shoreline Master Program. The figure on page 9 of the Critical Area Report shows Wetland D terminating at the Ordinary High Water Mark of a Type S Water, a side channel of the mainstem Yakima River (Figure 1).




Figure 2. This recent image from Google Earth has been highlighted with the approximate locations of the old easement, the new easement, Wetland D, and a Yakima River Side Channel. It is intended to demonstrate that this wetland is in direct connection with the Yakima River and falls under the Shoreline jurisdiction (KCC 17B) and not the Critical Area jurisdiction (KCC 17A).

We do not dispute that Wetlands C and D are likely influenced by irrigation practices on the pasture south of them, but they are also hydraulically connected to the mainstem Yakima River as they are relic channel scars within the channel migration zone. These wetlands provide important fish and wildlife habitat as they are directly connected to the Yakima River, just east of the areas shown in the Critical Areas report (Figure 2).

It is our understanding that Ms. Horish recently willingly relocated the existing easement across parcel 546534 to access parcel 516534. The new easement location results in the need for a new driveway that follows the terrace edge of the Yakima River floodplain and its associated side channels and wetlands; thereby creating a need for additional mitigation and potential variances from existing code. The proposed driveway falls within the buffer requirements for the Shoreline Master Program (KCC 17B) as the wetlands are in direct connectivity with side channels of the Yakima River. **The Reasonable Use considerations under the Critical Areas Code (KCC 17A) are helpful for considering impacts, but KCC 17A is not applicable in this location for this project and we recommend reconsideration of the Shoreline Variance as originally proposed.**

Thank you for the opportunity to comment on the Horish Shoreline Variance application for the proposed driveway and subsequent future residence on parcel 516534. The Washington Department of Fish and Wildlife (WDFW) is familiar with the project area, we've reviewed the application materials available on file, and we are neighboring landowners along the Yakima River. This project area includes a dynamic and complex reach of the Yakima River that provides critical habitat for anadromous and resident fish as well as other wildlife worthy of protection.

The parcel under review has numerous critical areas within the Shoreline jurisdiction that should be considered. The Yakima River, its side channels, and the riparian habitat along the floodplain are Fish and Wildlife Habitat Conservation Areas (FWHCA). The river in this location is home to two species listed as threatened by the Endangered Species Act (Mid-Columbia River Steelhead and Columbia River Bull Trout). This is one of the few areas in the mainstem Upper Yakima River with significant steelhead spawning and this reach consistently provides spring chinook salmon and coho salmon spawning and rearing habitat along with other native resident trout and other native species. The large wood and meandering channels create and maintain excellent fish habitat. The very features that create excellent fish habitat can also create dangerous places for people and infrastructure.




Figure 1. This figure shows the meandering nature of the Yakima River channels in the vicinity of the subject property (red circle). This figure comes from an October 6, 2023 <u>Memo</u> from Aspect Consulting to the Teanaway Ridge, LLC for RU-23-00001.

This parcel has a very real flood risk as it is within the Yakima River Channel Migration Zone (CMZ). The lidar and imagery show channel scars throughout this parcel and a recent CMZ report for a nearby project clearly confirms the active channel present within this parcel (Figure 1). From the site plan, it is difficult to tell exactly where the driveway and/or home is proposed relative to the southerly side channel of the Yakima River on the parcel. Currently, the river appears to be migrating toward the north, but as part of the active channel migration zone, we can anticipate that the river will return to its southerly alignment at some point (see Figure 2). Planning for this change now will minimize the need for emergency actions in the future. This parcel is mapped as a special flood hazard area by FEMA and flood and/or erosion risks are likely to increase with vegetation clearing and removal to accommodate road construction and home construction.

Any crossing of the channels or work with that occurs in, over, or near the channels of the Yakima River floodplain is likely to require a Hydraulic Project Approval (HPA) permit from WDFW. Information about our permits and processing can be found at this <u>link</u>, or feel free to reach out to us directly.

There does not appear to be adequate information provided about the existing critical areas within the Shoreline jurisdiction, the potential for Channel Migration at the site, or location of proposed structures to properly evaluate the potential impacts to critical areas, including critical habitat for federally threatened steelhead and other important anadromous fish resources. **WDFW recommends a full critical areas report be completed for the project that includes a channel migration study, to better understand the potential impacts to the Shoreline environment and critical areas on the site.**

Hi Bradley,

I've attached our earlier comments on this project for the Shoreline Variance and Reasonable Use applications. As we've stated earlier, WDFW believes this project falls under the Shoreline regulations, and not the critical areas regulations, where the new proposed driveway is adjacent to Wetland D. Additionally, the critical areas report does not adequately address all fish and wildlife habitat conservation areas or Priority Habitats and Species, nor does it address frequently flooded areas or the Channel Migration Zone.

We do not believe adequate mitigation is proposed for the impacts to the wetland buffer within the Shoreline Jurisdiction with construction of the proposed driveway.

We'd be happy to discuss this more with the County and/or proponents of the project.

This will mark the third consultation that I have provided for this ground disturbing activity. I have requested a survey under SV-23-00001, and RU-24-00001. I reiterate that request now, it seems this project continues to move forward without heed to it's potential impact to cultural resources.

Please consider the following.

SEPA regulations concerning responsibility are clear, in this instance it would be the County held responsible for any damage to historic properties.

WAC 197-11-080, specifies if information on significant impacts is not known, agencies shall obtain and include the information in the environmental documents if the costs are not exorbitant. When there are gaps in relevant information or scientific uncertainty concerning significant impacts, agencies must state such information is lacking or that substantial uncertainty exists. If the agency proceeds, it shall indicate in environmental documents its worst case analysis and the likelihood of occurrence.

The THPO considers DAHP the regulatory authority off Indian lands. A DAHP recommendation for cultural resource investigations is viewed by the THPO as a requirement. If such a recommendation is ignored, we recommend the County review RCW 27.53.060 <u>https://apps.leg.wa.gov/rcw/default.aspx?cite=27.53.060</u> and RCW

I have reviewed the SEPA checklist and associated documents. I have concerns regarding impact to park property and future maintenance requirements with the water conveyance at this location. The landowner has already diverted a flow of water from their property onto state property into existing drainage.

The following are questions/comments received from park staff:

- 1) Have the landowners actions been approved through the Department of Ecology through a water mitigation plan?
- 2) Has the water conveyance been engineered?
- 3) Source of the water and potential future impacts?
- 4) The landowner should have an approved water mitigation plan through the Department of Ecology and the County.
- 5) This has been an ongoing issue with private property owners diverting their water flow onto State Parks property without approval from the Department of Ecology and State Parks.
- 6) The added water flow has caused flooding up against the Palouse to Cascades Trail (PTCT) which has caused erosion of the trail base in certain areas.
- 7) Recommend requiring the landowner to convey the water entirely on private property should the access be approved.

Thank you for contacting the Washington State Historic Preservation Officer (SHPO) and Department of Archaeology and Historic Preservation (DAHP) and providing documentation regarding the above referenced project. These comments are based on the information available at the time of this review and on behalf of the SHPO in conformance Washington State law. Should additional information become available, our assessment may be revised.

Our statewide predictive model indicates that there is a high probability of encountering cultural resources within the proposed project area. This is due, in part, to the proximity of the proposed project area to the Yakima River, a resource known to have been important to both Native Americans and settlers in this area. Further, the scale of the proposed ground disturbing actions would destroy any archaeological resources present. Identification during construction is not a recommended detection method because inadvertent discoveries often result in costly construction delays and damage to the resource. Therefore, we recommend a professional archaeological survey of the project area be conducted and a report be produced prior to ground disturbing activities. This report should meet DAHP's <u>Standards for Cultural Resource Reporting</u>.

We also recommend that any historic buildings or structures (45 years in age or older) located within the project area are evaluated for eligibility for listing in the National Register of Historic Places on Historic Property Inventory (HPI) forms. We highly encourage the SEPA lead agency to ensure that these evaluations are written by a cultural resource professional meeting the <u>SOI</u> <u>Professional Qualification Standards in Architectural History</u>.

Please note that the recommendations provided in this letter reflect only the opinions of DAHP. Any interested Tribes may have different recommendations. We appreciate receiving any correspondence or comments from Tribes or other parties concerning cultural resource issues that you receive.
