Any person has the right to comment on the application and
request a copy of the decision once made. Appeal procedures
can vary according to the type of decision being appealed, and
are described in Kittitas County Code, Title 15A.

Environmental Review (SEPA): The County expects to issue
a Determination of Non-Significance (DNS) for this proposal,
and will use the optional DNS process, meaning this may be the
only opportunity for the public to comment on the environmen-
tal impacts of the proposal. Mitigation measures may be
required under applicable codes, such as Title 17 Zoning and
the Fire Code, and the project review process may incorporate
or require mitigation measures regardless of whether an EIS is
prepared. A copy of the threshold determination may be
obtained from the County.
