- THIS SURVEY WAS PERFORMED USING A NIKON DTM-521 TOTAL STATION IN CONJUNCTION WITH A TRIMBLE R8 GNSS GPS. THE CONTROLLING MONUMENTS AND PROPERTY CORNERS SHOWN HEREON WERE LOCATED, STAKED AND CHECKED FROM A CLOSED FIELD TRAVERSE IN EXCESS OF 1:10,000 LINEAR CLOSURE AFTER AZIMUTH ADJUSTMENT. IT IS NOT WITHIN THE SCOPE OF THIS PROJECT TO STAKE THE INDIVIDUAL PARCEL BOUNDARY CORNERS.
- THIS SURVEY MAY NOT SHOW ALL EASEMENTS WHICH MAY PERTAIN TO THIS PROPERTY.

- THE PORTION OF LOT 16, AS SHOWN ON SHEET 1 OF THIS SURVEY, SITUATED IN THE SOUTHWEST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 17 IS NOT INCLUDED IN THE QUIT CLAIM DEED RECORDED UNDER AUDITOR'S FILE No. 461994, RECORDS OF KITITITAS COUNTY, STATE OF WASHINGTON. THE ENTIRE SOUTHWEST 1/4 OF THE SOUTHWEST 1/4 WAS DEEDED TO JAMES AND EDWARD HAND, MARCH 14, 1920 BY THE NORTHERN PACIFIC RAILROAD IN DEED No. 8067 W. IT IS MY INTERPRETATION THAT THE SUBJECT PROPERTY WAS INTENDED TO BE INCLUDED IN THE AFOREMENTIONED QUIT CLAIM DEED (AFN: 461994) BUT WAS INADVERTENTLY OMITTED.

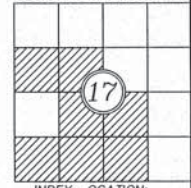

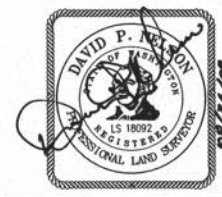
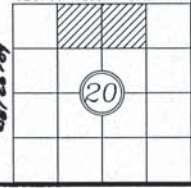
