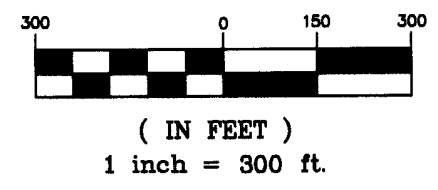


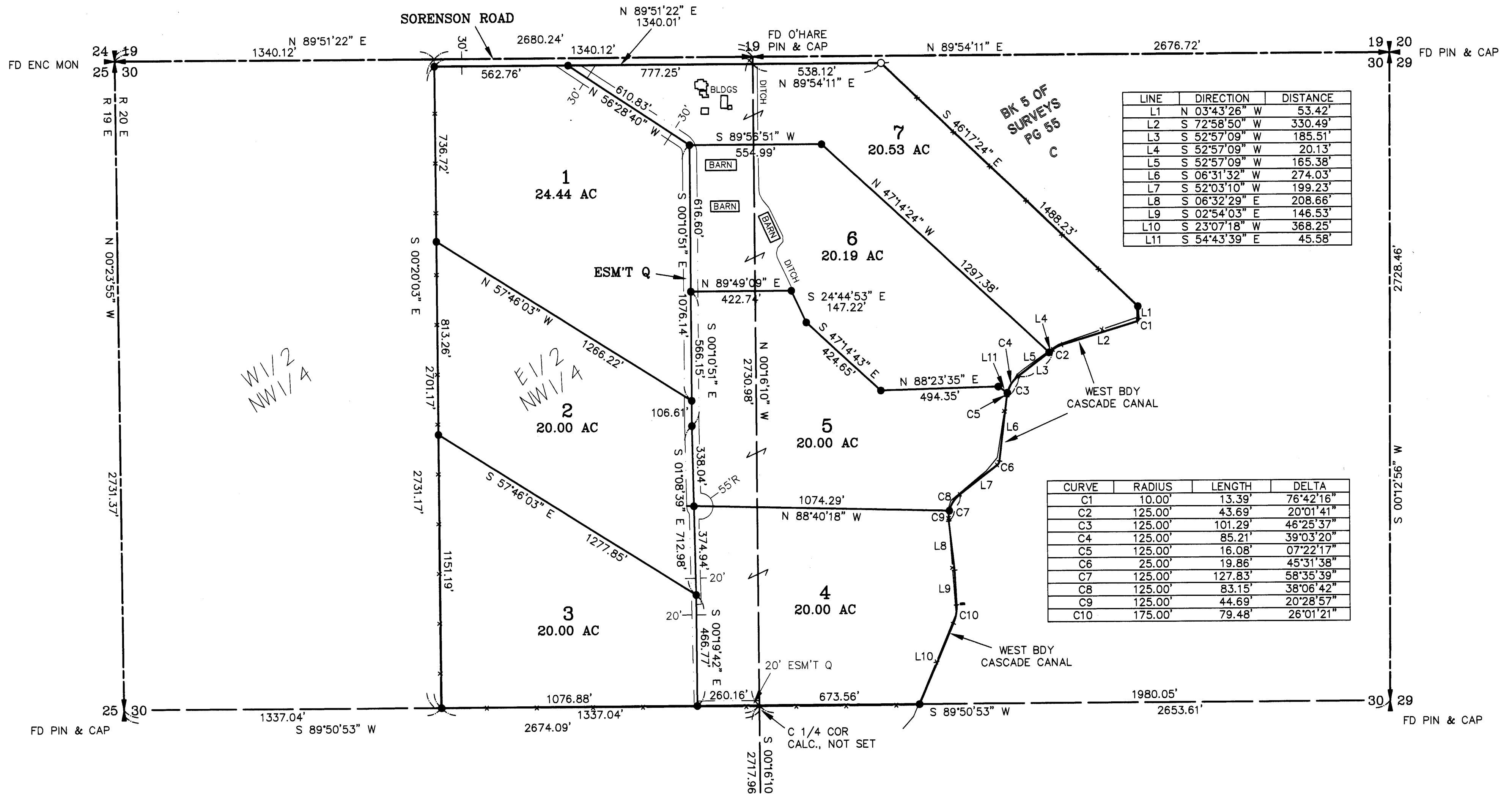
PART OF THE NORTH HALF OF SECTION 30,

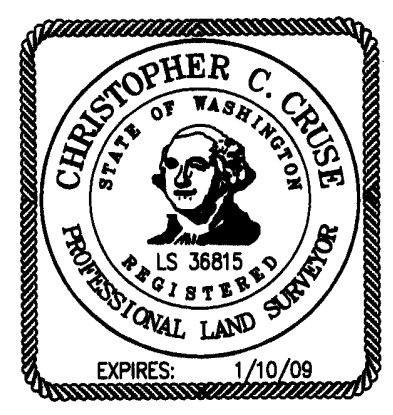
