Pursuant to RCW 36.70B.130 and KCC 15A.06, notice is hereby given that Kittitas County Community Development Services granted approval for the Schnebly Intervening Ownership Application (SG-12-00005) on November 6, 2012. The applicant, Craig P. Schnebly property owner, is proposing to divide his parcel based on the intervening ownership of North Branch Canal per Kittitas County Code 17.08.327. The site is located approximately 4.5 miles north of the City of Kittitas, at 1063 Lester Road, in a portion of Section 13, T18N, R19E, WM in Kittitas County, bearing Assessor's map number 18-19-13000-0035.
