The following changes must be made prior to preliminary approval:

 To limit the number of accesses onto the county road system, the plat must serve lots B&C and D&E from joint-use driveways. Direct access from an individual lot to the County Road shall not be permitted unless no

other alternative exists. Newly created lots shall access onto an internal road system and not directly onto a County Road, unless approved by the County Engineer. Lots

adjoining County Roads shall access from the lowest classified road or from a joint-use driveway, when possible. Police, fire, ambulance, and other emergency stations shall have a right to direct access to County roads.

Washington State Department of Health – Office of Drinking Water

The applicant indicates the water utility is "existing". It appears that this is an existing onsite private well. Please confirm.
