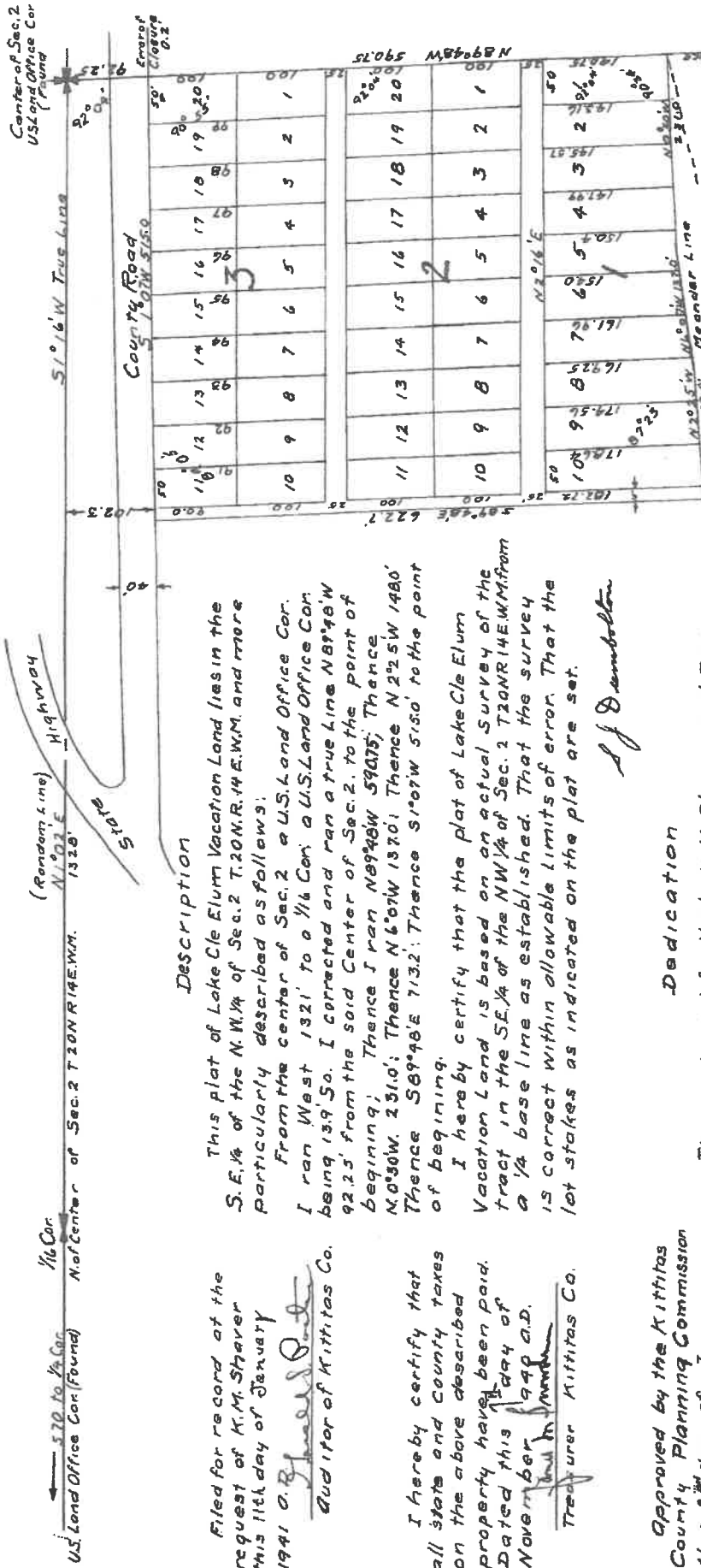


# LAKE CLE ELUM VACATION LAND

### Description

This plat of Lake Cle Elum Vacation Land lies in the S.E. 1/4 of the N.W. 1/4 of Sec. 2 T.20N.R.14E.W.M. and more particularly described as follows:

From the center of Sec. 2 a U.S. Land Office Cor. I ran West 1321' to a 1/4 Cor. a U.S. Land Office Cor. being 139 So. I corrected and ran a true line N 89° 48' W 92.25' from the said Center of Sec. 2. to the point of beginning; Thence I ran N 89° 48' W 590.75'; Thence N. 0° 30' W. 231.0'; Thence N 6° 07' W 1820'; Thence N 2° 25' W 1480'; Thence S 69° 48' E 713.2'; Thence S 1° 07' W 5150' to the point of beginning.

I hereby certify that the plot of Lake Cle Elum Vacation Land is based on an actual survey of the tract in the S.E. 1/4 of the N.W. 1/4 of Sec. 2 T.20N.R.14E.W.M. from a 1/4 base line as established. That the survey is correct within allowable limits of error. That the lot stakes as indicated on the plat are set.
