 - Please pick up a copy of the SEPA Checklist if required)

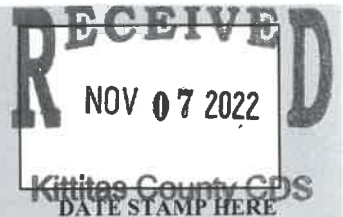
