**Purpose:** Notification of Receipt of Approved Substantial Development Permit (SDP)

On 10/30/2007, the Department of Ecology received notice that Kittitas County approved your application for an SDP. Your permit allows improvements to the Big Pines Recreation Area and includes installation of a geogrid base mat over existing boat access area. The project also includes regrading, paving, and providing drainage for existing site roads and parking areas, installation of vault toilets and a septic vault, removal of a shop slab, and installation of commercial fire rings within shoreline jurisdiction and the riparian area of the Yakima River.

By law, local governments must review all SDPs for compliance with the following:

- The Shoreline Management Act (Chapter 90.58 RCW)
- Ecology's Substantial Development Permit approval criteria (Chapter 173-27-150 WAC)
- The Kittitas County Local Shoreline Master Program

Local governments, after reviewing the SDP for compliance, are required to submit the SDPs to Ecology for filing.

Your approved SDP has been received and filed by Ecology.

### **What Happens Next?**

Before you begin activities authorized by this permit, the law requires you to wait at least 21 days from the date we received the decision letter from Kittitas on 10/30/2007. This waiting period allows anyone who (including you) disagrees with any aspect of this permit, to appeal the decision to the state Shorelines Hearings Board. You must wait for the conclusion of an appeal before you can begin the activities authorized by this permit.

If no appeal is submitted you may begin activities any time after 11/20/2007.

The Shorelines Hearings Board will notify you by letter if they receive an appeal. We recommend, however, you contact the Shorelines Hearings Board before you begin permit activities to ensure no appeal has been received. **Other federal, state and local permits may be required in addition to this shoreline permit.**
