Jeff, in order to properly review this project for flood impacts, I need the 100-year floodplain drawn on the short plat. I need to ensure that there is a buildable area outside of the 100-year floodplain on all parcels. This will prevent the landowner from needing to hire a hydraulic engineer to do a study. Unfortunately the parcels lines and floodplain boundaries on our maps are not accurate enough to make a visual determination.

For review purposes, the 200' shoreline jurisdiction should also be included on the short plat. The location of Big Creek should be shown for reference.

And, it's hard to tell through the trees where the driveway is for 4686 Nelson Siding Road, which crosses the subject property. I need to know the location of the driveway as well.
