Notice is hereby given that on April 3, 2017, conditional preliminary approval was granted to Chris Cruse authorized agent for Ritch Brownlee, landowner, for a short plat application to subdivide approximately 89.40 acres into One 21.96 acre parcel and one 67.44 acre parcel .
